




Five-Year Budget History






Active Transportation Plans 2020 SCP Call 1: Active Transportation and Safety



- May 2025: CARB staff notified SCAG via email that they have accepted SCAG's determination that Connect SoCal 2024 meets the regional GHG emission reduction targets
- TBD: CARB will release evaluation report

CARB to Update GHG Targets by Fall 2026

- SCAG and other MPOs have asked that CARB maintain current targets – which itself will be a difficult challenge.
- Two of CARB's proposed target scenarios are based on Scoping Plan VMT goals not constrained by funding or feasibility.
- Instead of an extensive target setting process, focus should be on supporting implementation.

CARB Target Scenarios Presented on 5/21

Illustrative Scenarios	New Statewide SCS GHG Per Capita Reduction (2035 vs. 2005)
Scenario 1 (Scoping Plan Based 2045 Target)	-22%
Scenario 2 (Scoping Plan Based Using 2030 and 2045 Targets)	-28%
Scenario 3 (Unchanged - Current Targets)	-19%

Scenario results reflect Statewide target calculation that will be further processed for each MPO

Opportunities to Improve SB 375

- SB 375 has improved long-range regional planning
 - Better integration of land use, housing, and transportation policies.
- · However, regional plans are not being implemented fast enough
 - Sustainable funding streams.
 - Supportive actions by state agencies or the legislature.
- A holistic review is needed to identify how best to achieve the suite of state and regional goals
 - Different goals related to housing, equity, land use, transportation, climate, and safety must be reconciled.
 - Action to achieve one objective can have unintended effect on achievement of another.

SB 375 Reform Framework

- Further Improve Process Integrity
 - Seek transparency in CARB's target setting methodology.
 - Seek consistency in air quality modeling for meeting state and federal goals
- Align State Planning Goals and Policies
 - Coordinate state policies early in the process.
 - Better integrate SCS and RHNA by alternating cycles (8 years).
- Prioritize Resources to Implement SCSs
 - Seek sustainable implementation sources (ongoing REAP 2.0-like source).
 - Prioritize state funding for key implementation strategies.
 - Support all GHG-reducing projects, even under an APS.

Cap-and-Trade – Background

- Cap-and-Trade is a state program for reducing greenhouse gas emissions. The program
 establishes a limit (cap) on emissions that may be produced. Companies covered by the
 program buy and sell (trade) emissions allowances. The funds raised from Cap-and-Trade
 are invested in other state programs that reduce greenhouse gas emissions.
- Over the last three years, Cap-and-Trade revenues have averaged \$4.4 billion per year.
- Current state law continuously appropriates Cap-and-Trade funds as follows:
 - 25% of proceeds for High-Speed Rail;
 - 20% of proceeds for Affordable Housing Sustainable Communities Program (AHSC);
 - 10% of proceeds for Transit and Intercity Rail Capital Program (TIRCP); and
 - 5% of proceeds for Low Carbon Transit Operations Program (LCTOP).
- The remaining 40% of proceeds are typically appropriated to various, discretionary programs.

Cap-and-Trade – Next Steps

- Governor Newsom's May Revision proposes to reauthorize Cap-and-Trade through 2045. In addition, he proposes a new annual spending plan:
 - \$1 billion of proceeds to High-Speed Rail
 - \$1.5+ billion of proceeds to Cal FIRE
- Stakeholders have concerns that the Governor's new spending proposal would eliminate funding for other priority programs that reduce greenhouse gas emissions.
- SCAG's Legislative Platform expresses support for reauthorizing Cap-and-Trade. The conversation is also an opportunity to uplift:
 - Long-term funding for regions to implement their SCS, such as permanent REAP-like funding;
 - · Regional equity targets in the distribution of funding;
 - The need for stable funding for transit operations and maintenance.






Logistics employment has not dropped following tariff news.

Conflict of Interest Policies

Current Policy Overview

 Article III outlines conflict of interest rules for SCAG Representatives and Article III.A allows for acceptance of gifts and political contributions if compliant with state and federal laws.

Identified Gap

- Existing language does not directly reference the Levine Act obligations.
- Existing language includes outdated references to applicable conflicts laws.

Staff Recommendation

- Add express reference to Levine Act obligations in Article III.A. (gifts/contributions) and Article III.D. (contract/decision-making disqualification).
- · Update citations and references and streamline wording for better understanding.

Conflict of Interest Policies

Proposed Language

ARTICLE III CONFLICT OF INTEREST

A. Gift and Political Contribution Prohibitions and Limitations - SCAG Representatives may accept gifts and political contributions but only up to the limits established by state law and only without violation of SCAG's Conflict of Interest Code and any state or federal conflict of interest rules and regulations. In accordance with Government Code Section 84308 ("Levine Act"), SCAG Representatives may not accept campaign contributions from a party or its agent(s) totaling more than \$500 if the party or its agent(s) is involved in a proceeding involving a license, permit, or other entitlement for use, including a contract, that is pending before SCAG or for 12 months following the final decision. SCAG Representatives shall disclose and recuse themselves from any proceeding involving a license, permit, or other entitlement for use, including a contract, if the SCAG Representative has received campaign contributions totaling more than \$500 from a party or its agent(s) involved in the proceeding within the previous 12 months. The Levine Act does not apply to contracts: under \$50,000, where no party receives financial compensation, between two or more public agencies, or competitively bid if required by law, agency policy, or agency rule to be awarded pursuant to a competitive process.

D. <u>Contract and Decision-Making Prohibitions and Disqualifications</u>

(1) In accordance with California Government Code Section 1090 et seq. SCAG Representatives shall not participate in making any contract or type of agreement involving SCAG if they are financially interested in the contract or agreement. To "participate in making a contract" includes decisions to create, modify, extend or renegotiate a contract. Most importantly, if an individual SCAG Representative is "financially interested" in a contract, Section 1090 prohibits the entire legislative body of which that individual is a member from taking action on a contract in which said individual has a financial interest. Thus, if a representative of a Member of the Regional Council has a financial interest in a contract, the Regional Council cannot consider or take action on that contract and it is not possible for the representative to simply disqualify themselves himself from any vote. For this reason, if SCAG contracting staff or legal counsel determine that a representative of a Member of the Regional Council has a financial interest in a bid or proposal for a contract, such bid or proposal will be disqualified from consideration by SCAG. Determining financial interest questions can be complicated and guidance from SCAG legal counsel should be obtained if any concerns exist regarding the applicability of Government-Gode Section 1090 to a contract, proposal or

- (2) In accordance with 2 CFR Part 200, Title 49 of the Code of Federal Regulations, Section 18.36 SCAG Representatives shall not participate in the selection, or administration of a contract supported by federal funds if a conflict of interest, real or apparent, would be involved. A real or apparent conflict-of-interest could arise not only in connection with SCAG Representatives themselves, but also if immediate family members are involved in a contract or because of the employment or potential employment of SCAG Representatives. The requirements of 2 CFR Part 200 Section 18.36 are complicated and guidance from SCAG legal coursel should be obtained regarding the applicability of 2 CFR Part 200 Section 18.36 to a contract supported by federal funds.
- (3) In accordance with California Government Code Section 87100 et seq., SCAG Representatives shall not make, participate in making or attempt to use their official position to influence a decision affecting SCAG when a conflict of interest, real or apparent, would be involved. Such a conflict of interest would arise because of a personal financial interest in a decision affecting SCAG. A financial interest would exist if it is reasonably foreseeable that the decision will have a material financial effect, distinguishable from its effect on the public generally, on an individual or his/her immediate family. If any SCAG Representative has a financial interest in a decision affecting SCAG within the meaning of the PRA Section 87100, that individual should recuse himself or herself from making or participating in such a decision and not use his or her position to influence or attempt to influence such a decision. Guidance on the proper recusal procedures to follow should be obtained from SCAG legal counsel who should also be consulted about questions regarding the PRA Section 87100.
- (4) In accordance with the Levine Act, SCAG Representatives should recuse themselves from participating in decision-making processes that involve a party or participant from whom the SCAG Representative has received campaign contributions over \$500 within the previous 12 months. This requirement does not apply to contracts: under \$50,000; where no party receives financial compensation; between two or more public agencies; or competitively bid if required by law, agency policy, or agency rule to be awarded pursuant to a competitive process.

International Airfare

Background

- Current policy only allows economy class airfare.
- At the direction of the EAC, staff reviewed international travel reimbursement best practices for board members.

Benchmark Review

- Staff contacted several peer agencies.
- Findings: Most agencies limit reimbursement to economy or most economic available fare.

Staff Recommendation

- Amend travel policy to allow upgrades to the next higher class within the main cabin (e.g., premium economy, economy plus) for international flights with scheduled flight time ≥ 5 hours.
- Business class and first-class airfare remain ineligible for reimbursement.

STIPENDS AND EXPENSE REIMBURSEMENTS

- E. Travel Policy for Representatives of Members of the Regional Council and SCAG Officers
- (3) SCAG representatives of Regional Council Members and SCAG Officers should, whenever possible, use SCAG staff to arrange all air travel. Only economy air travel is allowed for domestic and short-haul international flights. However, for international flights with a scheduled flight time of five (5) hours or more, travel in the next class within the main cabin, commonly referred to as premium economy or economy plus, is permitted. Business class and first-class travel are not eligible for reimbursement. Except for air travel, whenever possible representatives of Members of the Regional Council and SCAG Officers should make their own surface travel and lodging arrangements and obtain reimbursement from SCAG for all expenses incurred. If SCAG representatives make their own air travel arrangements and if the cost of airfare significantly exceeds costs regularly paid by SCAG for air travel, approval of SCAG's President will be required before reimbursement will be made.

Background

- In the South Coast region, mobile sources are responsible for more than 80% of NOx emissions and about 30% of PM2.5 emissions.
- Statewide, about 40% of greenhouse gas (GHG) emissions come from mobile sources.
- NOx and PM2.5 threaten public health and GHGs lead to climate change which has exacerbated extreme heat days, drought, and wildfire in Southern California.
- Failure to meet requirements of the Federal Clean Air Act (CAA) means sanctions may be imposed, jeopardizing transportation funds.
- On April 6, 2023, the Regional Council adopted the SCAG Clean Transportation Technology Policy Resolution, defining clean transportation technology, affirming SCAG's technology neutral position, and affirming the need for equitable access to new technologies.

- Federal policies, such as the Infrastructure Investment and Jobs Act (IIJA) and the Inflation Reduction Act (IRA), provided significant funding for clean transportation, with hundreds of billions of dollars of planned investment in transportation systems and technologies.
- The "Unleashing American Energy" executive order revoked the initiative to have EVs account for half of new cars sold by 2030.
- Set in motion Congressional revocation of Clean Air Act waivers that allow California to establish vehicle emission standards. On Thursday 6/12, President Trump signed the waivers.
- Recent actions have created enormous policy uncertainty across the entire transportation industry.




Highest Registration and Attendance in Three Years
